



LIABILITY RELEASE AND INDEMNIFICATION FORM

I, the undersigned participants, request voluntary participation in the Dallas Team Handball Club ("The Club") practices, activities and events from January 1st, 2025 to December 31st, 2025 at Mustang Park Recreation Center and at all facilities used for its activities and events which are hereinafter referred to as the "activity".

I consent to my participation in the activity and acknowledge that I fully understand my participation may involve risk of serious injury or death, including losses which may result not only from my own actions, inactions or negligence, but also from the actions, inactions or negligence of others, the condition of the facilities, equipment, or areas where the activity is being conducted, and/or the rules of play of this type of event or activity. I understand that if I have any risk concerns, I should discuss the risks associated with participation with the activity coordinators and staff, before I sign this document and before the activity begins.

Release:

I hereby release and hold harmless the City of Irving, Dallas Team Handball Club, its board of directors, officers, employees, volunteers, other participants, and agents (collectively, the "Released Parties"), of and from, and do discharge and waive, any and all claims, demands, losses, damages, and liabilities that I may have or sustain with respect to any and all damage and/or injury, of any type, arising out of my participation. I also agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

I have noted on the back of this form any medical/health problems of which the staff should be aware and certify that I am in good health with no physical condition that would prevent participation in this activity. Furthermore, I agree to use my personal medical insurance as a primary medical coverage payment if accident or injury occurs. I consent to emergency medical treatment in the event such care is required. I agree to pay all costs associated with medical care and transportation.

Indemnification:

I further agree to indemnify, save and hold harmless the Released Parties from any and all claims, demands, losses, damages and liabilities for indemnities, contribution or otherwise with respect to any damage and/or injury, of any type, arising from my participation. I also agree that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Release and is intended to be as broad and inclusive as is permitted by the laws of Texas and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
